Form can be found on Flexbene.com</p> <p>The letter must include the diagnosis or symptoms for which you, your spouse, or dependent are being treated, along with specific information on how the product or service is intended to alleviate symptoms and cure the condition.</p> <p>Submitting the Letter of Medical Necessity <i>does not</i> guarantee that the expense will be reimbursed. You <i>must</i> submit a new letter each year – they cannot be approved indefinitely.</p> <ul style="list-style-type: none"> Air purifier Automobile Modifications Blood Storage (<i>not to exceed six months</i>) Calcium Supplements (<i>osteoporosis</i>) Cord Blood Storage (<i>specific condition required</i>) Dietary Supplements (<i>to treat a specific medical condition</i>) Electrolyte Replacements (<i>Pedialyte</i>) Fiber Supplements Glucosamine (<i>arthritis</i>) Hair Loss Treatment (<i>due to a specific medical condition</i>) Herbal Remedies (<i>by a licensed provider</i>) Homeopathic Medicines (<i>by a licensed provider with Rx</i>) Hormone Supplements Humidifiers (treat specific medical condition) Incontinence Products Lodging (<i>up to \$50 per night, subject to additional conditions</i>) Massage Therapy (<i>to alleviate pain due to a medical condition</i>) Nutritionist Orthodontia for adults Orthopedic shoes (<i>only custom-fitted shoes</i>) Oxygen Probiotics Retin-A (<i>for the treatment of acne</i>) Sperm Storage (1 yr.
